## **Statement of Compliance**

<u>Duplex CSA Limited</u> Herein declare that the cable assemblies supplied to Duplex CSA Ltd. are in compliance with the RoHS2 Directive 2011/65/EU on the restriction of the use of certain Hazardous Substances in electrical and electronic equipment (RoHS), and European REACH Regulation No 1907/2006 regarding Substance of Very High Concern.

Our RoHS compliant products do not contain or contain less than maximum concentration limits Mercury (Hg 0.1%), Cadmium (Cd 0.01%), Hexavalent Chromium (Cr+6 0.1%), Poly Brominated Biphenyls (PBB 0.1%), Poly Brominated Diphenyl Ethers (PBDE 0.1%). The concentration of Lead (Pb) of some of our products is above threshold 0.1%, which is exempt under the current RoHS Directive.

We are regularly monitoring the continuing additions of Substances of Very High Concern (SVHC) to the Candidate List, which is the first step of the REACH authorization procedure. To date, 181 substances have been identified as SVHC and published on the Candidate list:

In general, the vast majority of our products do not contain any of the published SVHC. SGS/CTi reports are normally available upon request within 48 hours. Any free-issued parts or customer-specified parts that may be supplied or requested by customers for use in final procedures are not covered by this statement of compliance and the customer is under the obligation of ensuring compliance.
